### *Time-of Service Payment Plans*

We have four time-of-service plans:

1. Time-of-service payment for chiropractic adjustments includes chiropractic adjustment, cold or hot packs, use of the *spinalator* and therapies lasting less than 8 minutes.

Therapies lasting longer than 8 minutes will incur additional charges.

2. Prepayment are available for chiropractic and massage

6 Chiropractic Visits           \$300 (\$30 savings)

6 Massages – 60 Minute       \$390 (\$60 savings)

6 Massages – 90 Minute       \$570 (\$60 savings)

3. Same day Multiple service.

If you receive multiple chiropractic treatments on the same day you receive 40% off of additional treatments.

Massage on the same day as chiropractic will receive 10% off.

### *Health Insurance*

We accept most insurance Out-of-Network benefits. However, not all insurance provides for chiropractic care in the same amounts. We will assist you in verifying your chiropractic coverage. You will be expected to pay your deductible first and are responsible for any co-insurance payments at each visit, or we will assist you with one of our payment plans.

There are a few plans we cannot file under: BCBS, Kaiser and other HMO plans but you are welcome to submit a detailed receipt from our office.

### *Personal Injury or Auto Accident*

### *Medicare*

We are a Non-participating Provider with Medicare. You are responsible for your co-payment, deductible, plus any charges that are not covered or disallowed by Medicare. Medicare covers ONLY the SPINAL ADJUSTMENTS and only allows a maximum number per year (20-24).
